

### NOTICE TO BIDDERS

Cassopolis Public Schools will accept sealed bids for a crew cab pick-up truck as described in the attached specifications. Bids will be accepted until 1:00 PM local time, Wednesday, January 10, 2024, at which time they will be publicly opened and read aloud. No oral, telephonic, telegraphic, e-mail or facsimile proposals will be accepted.

Bid submissions shall be firm for one-hundred (100) days from the date of bid opening. Bids must be signed by the bidder using the proposal form provided. Three (3) signed copies of the proposal should be addressed to the attention of:

All bids shall be accompanied by a sworn statement disclosing any familial relationship that exists between the owner(s) or any employee of the bidder and any member of the Cassopolis Public Schools Board of Education or the Superintendent of Cassopolis Public Schools. The Cassopolis Public Schools Board of Education shall not accept a bid that does not include a sworn and notarized familial relationship disclosure statement. All bids shall include an Affidavit of Compliance – Iran Economic Sanctions Act in compliance with "Iran linked business" within the meaning of the Iran Economic Sanctions Act. Bids must be marked on the envelope, "Bid for Pick-up Truck," and the bidder's name must be identified on the envelope. Bids should be addressed to James English, Director of Finance, Cassopolis Public Schools. Cassopolis Public Schools reserves the right to accept or reject all or any portion of a bid and is not bound to accept the low bid. A bid may be rejected, if not accompanied by any data required by the Bidding Documents, or which is in any way incomplete or irregular. Cassopolis Public Schools shall have the right to waive informalities or irregularities in a bid received, and to accept a bid which, in the judgment of Cassopolis Public Schools, is in the best interests of Cassopolis Public Schools.
